Andrew is a barrister at Resolution Chambers in Hong Kong, and an associate member of 5 Stone Buildings, a leading Chancery law set, in London. A dual-qualified English and Hong Kong barrister, holding full practising rights in both jurisdictions, Andrew is frequently instructed in a wide range of commercial and Chancery disputes, encompassing commercial, trusts, pensions, and private international law, often with a cross-border or international element. The Legal 500 lists him as a leading junior in commercial disputes, describing him as "practical, user-friendly, hard-working, and brilliant at thinking on his feet."

Before coming to the Bar, Andrew obtained a doctorate from Cambridge University in the field of Renaissance literature, and after that taught for several years at one of Beijing's top universities. He converted to the law by way of Graduate Diploma in Law (distinction), holds an LLM (with specialisation in International Dispute Resolution) from the University of London, and has completed the Chartered Institute of Arbitrators (CI Arb) Diploma in International Arbitration and the Institute of Art and Law (IAL) Diploma in Art Law. He has also completed specialist Society of Trust and Estate Practitioners (STEP) qualifications in international trust management, trust disputes, international succession, foundations, and funds.

Andrew is recognised, in particular, for his expertise and experience in the fields of trusts and personal property, and has been instructed in numerous disputes relating to such fields, including crypto-asset disputes. Andrew recently appeared on behalf of the guardian of an MIP in the case of *Re WSY*, in which a trust of around HKD 270 million was established for the MIP, in addition to the provision of substantial assets in the MIP's own name. He has acted as counsel for the prominent cryptocurrency investor and entrepreneur, Roger Ver, in his dispute with OKEx cryptocurrency exchange (*Ver, Roger Keith v OKEX*

Fintech Company and Xu, Ming Xing), as well as for the sellers of BitOcean, a Japanese digital currency trading platform, in their dispute with the subsidiary of a Hong Kong listed company. Andrew was advocate at trial and for the successful appellant on appeal to both the Court of Appeal and Court of Final Appeal in the case of Kan Lai Kwan v Poon Lok To Otto and HSBC International Trustee Limited, which established the treatment of trusts in divorce in Hong Kong, and has acted as advocate in numerous other matters before all levels of court and tribunal. He is currently instructed in the high-profile Lo Family Trust dispute.

Andrew has published widely in (among others) *Trusts & Trustees* and the *Law Quarterly Review*, and, in partnership with LexisNexis Hong Kong, has authored the “trusts disputes” series of practice notes for their Practical Guidance series. He is a member of the Panel of Arbitrators of the Shanghai Arbitration Commission, and has recently advised the HK government on arbitration-related matters.

He is a full member of the Society of Trust and Estate Practitioners (TEP), a Fellow of the Chartered Institute of Arbitrators (FCIArb), a fellow of the Hong Kong Institute of Arbitrators (FHKIArb), a member of the Institute of Art and Law (IAL), and a member of the Hong Kong Bar Association Committee on Land, Trust and Probate (ComLTP).

Andrew is British, holds British and Irish citizenship, and has Hong Kong Permanent Residency. He is a native English speaker, has experience dealing with contractual and other documents in simplified Mandarin Chinese, and has passed the HSK (汉语水平考试) at level 8.
